Institutional Outcome Assessed: Critical Inquiry & Reflection: Ask and propose answers to thought-provoking questions through inquiry and analysis.

Division Level Outcome Assessed: SLO #1 Conduct inquiry and analysis of complex issues using interdisciplinary or transdisciplinary theoretical and methodological frameworks. Students synthesize key findings and present evidence in a coherent and professional manner while reflecting on how inquiry applies to critical global issues.
